Welcome to Rotary !

You are a member of a worldwide organization of business and professional leaders that provides humanitarian service, encourages high ethical standards in all vocations, and helps build goodwill and peace in the world. Approximately 1.2 million Rotarians belong to more than 32,000 clubs in more than 200 countries and geographical areas.

The Rotary Club of Victoria was formed in 1913 when members of the Rotary Clubs of Seattle and Vancouver brought the idea to Victoria. The Victoria Club (#90 in the world) has undertaken literally thousands of local and international projects. Two well-recognized local projects were The Chamber of Commerce and what is now Tourism Victoria; our Club established both.

Why Join Rotary?

Membership in Rotary offers a number of benefits, including:

- Effecting change within the community
- Developing leadership skills
- Gaining an understanding of — and having an impact on — international humanitarian issues.
- Developing relationships with community and business leaders

Each Rotary club strives for a membership that is an up-to-date and progressive representation of its community's business, vocational, and professional interests.

The Membership Process

In most cases, a person being considered for membership is invited by a member sponsor to attend one or more club meetings to learn more about Rotary. The sponsor may then submit the name of the candidate to the club's membership committee. Others who are interested in membership, but do not know a Rotarian, can contact a club directly.

Object of Rotary

The Object of Rotary is to encourage and foster the ideal of service as a basis of worthy enterprise and in particular to encourage and foster:

FIRST: The development of acquaintance as an opportunity for service;

SECOND: High ethical standards in business and professions. This includes the recognition of the worthiness of all useful occupations and the dignifying of each Rotarian's occupation as an opportunity to serve society;

THIRD: The application of the ideal of service in each Rotarian's personal, business and community life;

FOURTH: The advancement of international understanding, goodwill, and peace through a world fellowship of business and professional persons united in the ideal of service.

Avenues of Service

The term "Four Avenues of Service" refers to the four elements of the Object of Rotary: Club Service, Vocational Service, Community Service and International Service. Although the Avenues of Service are not formalized in constitutional documents, many Rotarians use this concept to describe the primary areas of Rotary activity.

Rotary's 4 - Way Test

One of the most widely printed and quoted statements of business ethics in the world is the Rotary 4-Way Test. It was created by Rotarian Herbert J. Taylor in 1932 when he was asked to take charge of a company that was facing bankruptcy. Taylor looked for a way to save the struggling company mired in depression-caused financial difficulties. He drew up a 24-word code of ethics for all employees to follow in their business and professional lives. The 4-Way Test became the guide for sales, production, advertising and all relations with dealers and customers, and the survival of the company is credited to this simple philosophy:

"Of the things we think, say or do:

Is it the truth?

Is it Fair to all concerned?

Will it build goodwill and better friendships?

Will it be beneficial to all concerned?"

What Is My Commitment As A Rotarian?

There are both time and financial commitments. Our club meets every Monday at noon in the Union Club.

Rotary members are able to make up missed meetings by attending other Rotary Club meetings as visiting Rotarians. Make-ups can also be accomplished by attending club, local or district meetings including meetings of project committees of our club.

To help you attend make-ups the meeting times and locations of other area clubs are listed in this Roster.

Rotarians are entitled and encouraged to attend committee and board meetings. Board meetings are generally held at 4:30 the third Wednesday of each month.

Financially you can expect to pay an initiation fee, annual dues and lunch costs. Donations to Rotary charities you will hear about are your choice.

How is the Club Run?

The President and Board of eight elected Directors are responsible for the smooth functioning of the club. The two vice-presidents (who are Directors) are chosen by the President. They are responsible for day to day club operations in consultation with the President. The President serves as the Club's spokesman and oversees the club's operation in conjunction with the Board.

The eight elected directors serve a two-year term. Four directors retire each year and are replaced by four new people. Directors are chosen by a nominating committee of four people elected each fall. Those elected, plus the President, Past President and President-Elect serve as the nominating committee. Six people are nominated to serve as Directors and in early December four are elected at a club meeting by secret ballot. Those directors start their term about seven months later commencing July first.

We choose our Presidents well in advance.

Eighteen months before a President takes office, that person is announced as President Designate at the same meeting as the next year's directors are elected. The President Designate is chosen by the nominating committee, as part of its mandate. However if the general membership at large wishes to elect someone else, they are free to do so, supported by 10 seconders. In that event the membership elects the President Designate. He then becomes President-Elect following July 1.
